The Government of Punjab is pleased to withdraw its order dated 14.06.2011 with regard to dispensing with the services of Ms. Parveen Bali and to reinstate her in service on her original post of Additional District & Sessions Judge alongwith all the consequential benefits like continuity in service, seniority, further promotions and all other service benefits. However, the officer shall be entitled to claim only 50% of the salary for the period in question i.e. from the date the officer had relinquished the charge till her reinstatement in service (including increments, allowances and revision of salary etc.). Further, her reinstatement in service is subject to the decision of Review Petition (Diary) No. 29444 of 2022 titled as "Punjab and Haryana High Court, Chandigarh through its Registrar versus Parveen Bali", which is pending before Hon'ble Supreme Court of India and further, that the officer will be adjusted against one of the vacancies meant for General Category out of total available vacancies, which have already been advertised, vide this Court's Notification No. 185 Gaz.I/VI.F.2 dated 14.11.2023.
