ORDER

Dated, Chandigarh, the 25th April, 2023

In exercise of the powers conferred under rule 6(1)(c) of the Haryana Superior Judicial Service Rules, 2007, the Governor of Haryana, on the recommendation of this Court, is pleased to appoint **Sh. Rajneesh Kumar** as Additional District & Sessions Judge in the State of Haryana, purely on provisional basis from the date he takes over as such, in the pay scale of Rs. 51,550-1,230-58,930-1380-63,070 plus usual allowances as sanctioned by the Haryana Government from time to time, with further orders that the said appointment is subject to the terms and conditions, i.e. **(i)** that he will be governed by the Haryana Superior Judicial Service Rules, 2007 in Haryana as well as other rules/instructions in the matter of leave, conduct, discipline and appeal, medical attendance, provident fund/NPS, travelling allowance and all other service matters etc. framed by the Government of Haryana and issued from time to time, **(ii)** that his appointment is subject to the fulfillment of all necessary conditions laid down in rules **(iii)** that his probation will be governed by Rule 13 of the Haryana Superior Judicial Service Rules, 2007 and he will be on probation for a period of two years, from the date of joining duty as decided by the Hon'ble Punjab and Haryana High Court, Chandigarh. The said appointment is subject to the successful completion of probation period as per rules **(iv)** that his appointment will be subject to the outcome of court case, if any, instituted/may be instituted in connection with his selection/appointment.




